 aforesaid containing about one acre part of late Scotts and all other the  
 land and premises late Scotts except the aforesaid Cottage and garden  
 devised to my brother James and also all that dwellinghouse and  
 garden situate at West Bagborough occupied by my Aunt Dow and also  
 the four fields of ground with an orchard and cottage in the occupa-  
 tion of Director Steele and the house and garden in the occupation of  
 William Fox also situate at West Bagborough aforesaid and all other  
 if any hereditaments belonging to me at West Bagborough aforesaid to  
 hold all and singular the said hereditaments and premises comprised in  
 this devise and situate in or near Sholway lane Somerton place and West  
 Bagborough as aforesaid unto and to the use of the said William & Mr.  
 Webster and my said son Robert Dernian his heirs and assignes &  
 upon the trusts herein after declared that is to say as to all that part of the  
 said Close of land late Abnourbys now inclosed leightways from the bottom

 or as to daughters be under that age and unmarried then my will
